What it takes to be a CFII

It is typically done after the CFI-A



What it takes to be a CFII

It is required at many flight schools.

A CFII needs no time off to work on their rating It slows the factory down



What it takes to be a CFII

Training is very procedural Easier than CFI-A

What it takes to be a CFII

CFII can reinstate all instructor ratings



Additional Rating to an Existing Instructor Certificate:

- 61.191 refers back to 61.183 (eligibility)
- 61.183(c)(2) Must hold an instrument rating on pilot cert
- 61.185(a)(3) Instrument rating aeronautical knowledge



Eligibility:

§ 61.183



§61.183 Eligibility requirements.

To be eligible for a flight instructor certificate or rating a person must:

- (a) Be at least 18 years of age;
- (b) Be able to read, speak, write, and understand the English language. If the applicant is unable to meet one of these requirements due to medical reasons, then the Administrator may place such operating limitations on that applicant's flight instructor certificate as are necessary;
- (c) Hold either a commercial pilot certificate or airline transport pilot certificate with:
- (1) An aircraft category and class rating that is appropriate to the flight instructor rating sought; and
- (2) An instrument rating or privileges on that person's pilot certificate that are appropriate to the flight instructor rating sought, if applying for—
- (i) A flight instructor certificate with an airplane category and single-engine class rating;



Aeronautical Knowledge:

§61.185 Aeronautical knowledge.

- (a) A person who is applying for a flight instructor certificate must receive and log ground training from an authorized instructor on:
- (1) Except as provided in paragraph (b) of this section, the fundamentals of instructing, including:
- (i) The learning process;
- (ii) Elements of effective teaching;
- (iii) Student evaluation and testing;
- (iv) Course development;
- (v) Lesson planning; and
- (vi) Classroom training techniques.
- (2) The aeronautical knowledge areas for a recreational, private, and commercial pilot certificate applicable to the aircraft category for which flight instructor privileges are sought; and
- (3) The aeronautical knowledge areas for the instrument rating applicable to the category for which instrument flight instructor privileges are sought.

Training for an instrument rating

Ten hours of instrument training for the Commercial Certificate Recency of experience endorsement for an IGI



Additional Privileges:

Training for the CFII as an additional rating Training for CFII initial rating if qualified under 61.195(h) Endorsement for the IRA, FII, knowledge tests Knowledge test endorsements: IRA, CFII add-on, CFII initial



Practical tests

How long is the training for an additional rating (CFII)?

Add on - 3-day class, 6 hours flight

How long is the training for initial?

Same Plus, two-day FOI class, 1.5 hrs spin training



What it takes to be a CFII

Must demonstrate Primary/Supporting or Control Performance Method



Why do a CFII as an initial?

Less to know No FOI for added CFI-A checkride – After passing CFII Best fit for Airline pilots



FARs that address CFII as an Initial

- 61.183(a)(2) Instrument rating on a pilot certificate Can't teach what you don't have
- 61.183(i) Spin training/instructional proficiency endorsement
- 61.185(a)(1) FOI and (a)(3) Aeronautical knowledge IFR
- 61.195(h) Qualified instructor to train initial CFIs



Qualified Flight Instructor for Initial CFI/CFII/MEI

2 years and 200 hours given or 400 hrs dual, 5 applicants (80% 1st time pass rate) Can only teach in a CFI/CFII initial 141 approved course



Qualified Flight Instructor for Initial CFI/CFII/MEI – Ground Only

AGI/CFI - 2 years and 40 hours given or 100 hrs teaching any 141 approved course, 2 years not required



CFI doing the training - Qualified for initial flight instructor regulations - 61.195(h)



Practical test lessons - Usually Holding, BAI, Navigation, or an Approach



Per the new CFII PTS

Must wear view-limiting device for unusual attitude recoveries and non-precision approaches



LPV meets the precision approach requirement—No DA limit is specified



Circle to land location - Maintain the altitude until in a position from which a descent can be made - Implies downwind or base
